Renewal of Group Life Insurance Policy for staff of Tamil Nadu Grama Bank from 07.09.2025 to 06.09.2026.

Our existing Scheme of Group Life Insurance Policy for all staff of our Bank covering natural/accidental/suicidal death will expire on 06.09.2025.

- 1. The main features as well as the operating guidelines of the Scheme for Group Life Insurance Policy are furnished as under:
- a) All staff of the Bank as on the date of commencement of the Policy i.e. 07.09.2025 will be covered. The insurance premium for the Group Life Insurance Policy will be borne by the Bank.
- b) Minimum & Maximum age of the staff will be 18 years and 60 years respectively.
- c) Life Insurance coverage for death due to any reason (natural/accidental/suicidal) of the staff will be effective immediately from the date of joining the scheme.
- d) The staff should be covered automatically without individual good health certificate and claims should be settled accordingly.
- e) There will be Retirements/Recruitments and Promotion from Cadre to Cadre/Scale to Scale during the insurance period and such staff will be excluded/included or upgraded to higher insurance coverage accordingly. The data will be shared on monthly basis with the Insurance Company. Any additional premium on account of upgradation of the staff and also on recruitment will either be adjusted with the premium pald for retiring staff or Bank will pay the premium on prorata basis for remaining period of insurance year, as the case may be.
- f) In case of unfortunate death of the insured staff, the insurance amount will be paid on submission of a claim form together with the death certificate.
- g) The payment will be made by the Insurance Company to Head Office, which in turn will credit the amount to the claimant widow/widower/PF nominee/legal heir(s) of the deceased employee, as the case may be.

- h) Please note that M/s. K M Dastur Reinsurance Brokers Pvt Ltd are the Bank's mandated broker to handle this policy.
